

YOUNG ARMENIAN COMPOSERS COMPETITION 2025

PROJECT TERMS AND CONDITIONS

Last updated: March 25, 2025

By agreeing to these terms, participants consent to the collection, processing, and storing of personal data, including photos and videos, in compliance with applicable data protection laws. This information will be used solely for competition documentation, the official website, and social media announcements. All data will be securely stored and retained for up to three years after the competition's conclusion. Participants may withdraw consent at any time by contacting [hello\(@\)primavera-foundation.am](mailto:hello(@)primavera-foundation.am). All personal information will be deleted upon withdrawal unless required for record-keeping purposes.

The applicant, parents/guardians, and teacher have read, understood, and agreed to the Terms and Conditions. Failure to abide by these rules and regulations will make the entrant ineligible to receive recognition or awards. Applicants under age 18 must have parent/guardian permission to participate.

Applicant agrees to comply with all applicable copyright laws. Original compositions are eligible for submission without the need for registered copyright, provided they adhere to copyright regulations.

ELIGIBILITY & COST

Application requirements

Eligible applicants include:

- Armenian composers living in Armenia between 18 – 35 years old (inclusive).
- Armenian passport holders, Armenian 10-year special passport holders or 5-year Armenian residence permit with Armenian nationality indicated;*
- Higher musical education (completed or in progress);
- Continuous residence in Armenia for one year prior to the year of application (confirmed by an Armenian tax residency certificate).

* Applicants must provide valid age-verifying documentation, such as a birth certificate or passport copy. Any discrepancies in age information may result in disqualification from the project.

Participants found to have provided falsified information will forfeit all rights to awards, recognition, and any future involvement in the project.

Required Submission Materials for All Applicants:

- Two links of video or audio recording of the original existing compositions, not transcriptions or arrangements: **one vocal-instrumental piece and one piece for a chamber ensemble (transcriptions or arrangements are not accepted).**
- Two scores for each composition (applications without score are not accepted)
- Artistic Biography
- A photo in JPG format (high resolution)
- Copy of the passport / Birth certificate
- Tax Residency Certificate
- Applicants must guarantee that they hold all necessary rights, including third-party rights, for any sheet music and recordings submitted for the project;
- Selected participants may be required to participate in promotional events, media appearances, and additional performances as part of the project's public engagement efforts.
- Recording Requirements: By submitting audio recordings and related materials, the applicant grants Primavera Charitable Foundation and its affiliates a non-exclusive, worldwide, royalty-free

license to use, reproduce, and distribute the recordings for promotional purposes related to the project. The artist retains full ownership of their recordings and may revoke this license in writing, with reasonable notice, if required for legal or personal reasons. If third-party rights are involved, the artist confirms they have obtained permission for all uses permitted here.

Successful applicants will be notified by email and phone and announced on Primavera Charitable Foundation social media profiles.

Prize

- The competition winner will be offered a commission contract to compose a new piece(s) for voice & piano (alternatively: guitar, violin, and cello or in ensemble). The royalty fee is from 200,000 to 600,000 AMD, depending on the quantity of works commissioned. All commissioned works will be performed on the stage this July, the performance will be professionally recorded (audio & video).

Cost

- Artists are responsible for covering their travel and accommodation costs, which are non-refundable. Primavera Foundation Armenia is not responsible for any costs associated with logistics. In the event of project cancellations or postponements due to unforeseen circumstances, Primavera Charitable Foundation will communicate alternative options, but holds no liability for reimbursing these expenses.

Legal Jurisdiction and Dispute Resolution

These Terms and Conditions are governed by the laws of the Republic of Armenia. Any disputes arising from participation in this project will be resolved through arbitration in Armenia, or if necessary, within the jurisdiction of Armenian courts. The participant agrees to submit to this jurisdiction for all matters related to these terms.

Changes to Terms and Conditions

Primavera Charitable Foundation reserves the right to modify these Terms and Conditions as needed. Participants will be notified of any significant changes by email or through an announcement on the official website. Participants have 7 business days to review and, if necessary, withdraw from the project if they do not agree with the new terms.
